### Dave Aiton, Compliance and Outreach, NHDES Subsurface Systems Bureau

Dave is the Compliance & Outreach Supervisor for the Subsurface Bureau of the New Hampshire Department of Environmental Services (NHDES). Prior to his roles as a regional inspector and outreach specialist with NHDES, he worked for over 18 years in the civil engineering field for survey and engineering firms in New Hampshire's lakes region.

#### Tim Carney, Bureau Administrator, NH Department of Education

Tim Carney is the Administrator of the Bureau of School Facilities (BSF) at the New Hampshire Department of Education. Tim has over 35 years of civil and environmental engineering experience in both the private and public sector. As the Bureau Administrator he oversees the approval and 5-year renewals for both public and nonpublic schools, provides facility related support to school facility managers, responds to school emergencies as appropriate, and assists other State and local agencies in areas of school facilities and safety.

#### Jonathan Cowal, Legal Services Counsel, NH Municipal Association

Jonathan provides both legislative and legal services to NHMA's member municipalities. Before joining NHMA, Jonathan served as a prosecutor in both Rockingham and Hillsborough County in the special victim's unit. Jonathan received his bachelor's degree from Bridgewater State University and his law degree from New England School of Law in Boston. Jonathan worked briefly as an associate attorney at the law firm of Falbo, Solari and Goldberg in Winthrop, Massachusetts before becoming an Assistant District Attorney for Essex County in 2015.

## Sophia Johnson, Health Officer Liaison Unit, NH DPHS

Sophia has focused her public health career on environmental hazards and local community engagement. She currently leads the Health Officer Liaison Unit within the NH Division of Public Health Services. In this role, she fulfills the mission to improve local public health workforce capacity. She provides training and technical assistance to local health officers across the State on problems ranging from hoarding conditions to septic failures to pest infestations. Sophia previously worked full time as an Environmental Health Specialist with the Manchester Health Department, performing food service inspections, executing an arboviral surveillance program, and conducting other sanitary inspections. She received her Master of Public Health from the University of New Hampshire and is a licensed Registered Environmental Health Specialist through the National Environmental Health Association. She also serves as Health Officer for her hometown of Chichester.

# Colleen Monks, Public Health Emergency Preparedness and Medical Reserve Corps (MRC) Director, South Central Regional Public Health Network

Colleen has worked in this role for over nine years and has been an emergency response volunteer in her community for twenty years.
