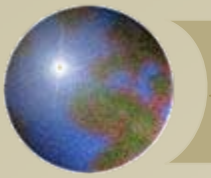


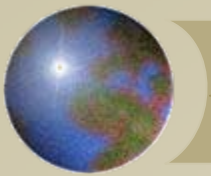

Our Purpose

 3. To strive for recognition of the public and environmental health professional as a member of the professional, administrative and scientific group engaged in the fields of public and environmental health.



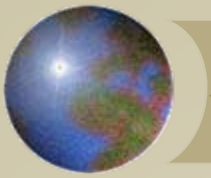
Our Purpose (cont.)

4. To encourage the employment of qualified public and environmental health professionals by governmental units and academia throughout New England.
5. To promote the conduct of educational courses of instruction and schools of training for the purposes of increasing the knowledge and proficiency of public and environmental health professionals.
6. To concern itself with the welfare, interests, and economic positions of the public and environmental health professionals.
7. To foster and promote public health laws and regulations throughout the states of Maine, New Hampshire and Vermont based on best available science and practices.
8. To cultivate social interaction among public and environmental health professionals and to establish a central body for the exchange of ideas and actions.



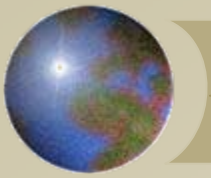
Membership

- Membership shall be open to all persons with a sincere interest in public and environmental health who are residents of or employed in the states of Maine, New Hampshire or Vermont and meet the following membership guidelines:
- **Associate member** – one actively engaged in the field of public or environmental health. Associate members may vote and are eligible to chair committees.
- **Active member** – associate members who are current members in good standing of the National Environmental Health Association. May be elected Chair or Vice Chair and may be a national Delegate.
- **Student member** – one actively enrolled in disciplines pertinent or related to public or environmental health.



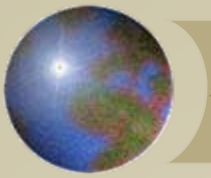
Membership (cont.)

- **Retired member** – any active or associate member provided he or she has been a member of the Association for at least five (5) years, has accrued at least twenty (20) years of service, or has retired because of age or disability.
- **Sustaining member** – individuals, firms, corporations, institutions or official agencies expressing an interest in the Association and its objectives
- **Honorary member** – any person for distinguished achievement or service in the fields of public and environmental health upon the approval of the Board of Directors.
