### PETITION FOR AN ADMINISTRATIVE INSPECTION WARRANT IN ACCORDANCE WITH RSA 595-B

2. In accordance with RSA 128:5 the Petitioner has the authority and duty to enforce public health laws and regulations. This includes the authority to conduct investigations into the safety and sanitary conditions of property and structures located within the town. In conducting such investigations the Petitioner is authorized by law to enter on private property, but he/she is not authorized to enter and inspect any living quarters located on the property unless he/she first has the consent of the property owner or specific authorization from a court of law.
3. The Petitioner has probable cause to believe that property located at:

## ADMINISTRATIVE INSPECTION WARRANT

This Court, having reviewed the Petition for the issuance of an Administrative Inspection Warrant, including the sworn affidavit of the Petitioner, hereby determines that there is probable cause to believe that the property identified in the Petition is unsafe and/or unsanitary and as such poses a risk to the occupants of the property and to the public.

The Court hereby authorizes the Petitioner to enter the identified property including any living quarters, either with or without the consent of the property owner and/or occupants, and fully inspect the property. Such inspection shall take place at the earliest convenience of the Petitioner, however, such inspection must occur after 8:00 a.m. and before 8:00 p.m. Following the inspection the Petitioner may take such action as is authorized by law.
